1	Are excessively noisy activities occurring?				
2	Is a barrier/enclosure or other noise control method (eg adjust beepers, relocate stationary plant, respite period) required to reduce the impact of noise on neighbours?				
3	Are construction activities including deliveries occurring strictly within approved working hours?				
4	Are construction activities planned and implemented giving consideration to adjacent neighbours / existing tenants etc operations?				
Hazardous Substances & Liquids					
1	Are all liquid containers stored in a secure, impervious bunded area?				
2	Are spill kits available and stocked with appropriate control equipment? (eg small booms, absorbent fabric/materials)

1	Is the site access controlled and adequately monitored? (ie by the s/c or kept closed)				
2	Is pedestrian access (including disabled and prams) being maintained around the construction site?

1	Are appropriate waste and recycling bins available on site?				
2	Is litter evident within the construction compound or around the site? (if yes, collect immediately)
